Pope's diary cleared as he battles double pneumonia

Pope Francis has shown the onset of double pneumonia, further complicating treatment for the 88-year pontiff, the Vatican said last night.

"The laboratory tests, chest X-ray, and clinical conditions of the Holy Father continue to present a complex picture," said a statement.

"(A) chest CAT scan which the Holy Father received this afternoon ... showed the onset of bilateral pneumonia that requires further pharmacological therapy," it added.

"Nevertheless, Pope Francis remains in good spirits," the statement said.

Bilateral pneumonia is an infection that affects both lungs, and can make breathing difficult.

Francis has been suffering from a respiratory infection for more than a week and was admitted to Rome's Gemelli hospital on February 14.

He is especially prone to lung infections because as a young adult he developed pleurisy and had part of one lung removed.

A Vatican official speaking on background earlier in the day, said the pontiff had not been put on a ventilator and was breathing on his own.

Ahead of the latest statement, the Vatican announced that all public events on the pope's calendar had been cancelled through Sunday.

The pope had been due to lead several events over the weekend for the 2025 Catholic Holy Year, which runs through to next January.

It is a special time of pardon and forgiveness for Catholics and the Vatican expects 32 million tourists to visit Rome throughout the year, including for a range of special audiences with Francis.

The Vatican said on Monday that doc-

tors had changed the pope's drug therapy for the second time during his hospital stay to tackle a "complex clinical situation". They described it as a "polymicrobial infection of the respiratory tract".

Doctors say a polymicrobial infection occurs when two or more micro-organisms are involved, and can be caused by bacteria, viruses, or fungi.


The Vatican has said Francis will stay in hospital for as long as necessary. It has not specified whether the pope is suffering from a bacterial or viral infection.

While a bacterial infection can be treated with antibiotics, viral infections cannot. Viruses usually have to run their course, but the patient can be assisted with other medicines to bring down a fever or help their body fight the infection.

Francis had part of one lung removed after a pulmonary infection as a young man and is prone to bouts of bronchitis in winter.

He has admitted in the past that he is a non-compliant patient, and even his close Vatican aides have said he pushed himself too far even once his bronchitis was diagnosed.

Notice of a decision by An Bord Pleanála in relation to the proposed Bray to City Centre Core Bus Corridor Scheme, all in the Counties of Dublin and Wicklow.

An Bord Pleanála has, on the 28th January 2025, in exercise of the powers vested in it by section 51 of the Roads Act, 1993, as amended, made an order to approve subject to conditions the proposed road as submitted by the National Transport Authority.

The conditions of the Board's decision are summarised as follows:

1. The proposed scheme shall be carried out and completed in accordance with the plans and particulars lodged with the application, except as may otherwise be required in order to comply with the following conditions.
 2. The proposed scheme shall be amended and provided for in accordance with the details set out below. Revised plans shall be submitted for the written agreement of the planning authority which provide for:
 - (a) Appropriate pedestrian facilities at the junction of Dublin Road and Shanganagh Park and Cemetery.
 - (b) The introduction of a cycle link at the Hill in Stillorgan.
 3. (a) All mitigation, environmental commitments and monitoring measures identified in the Environmental Impact Assessment Report (EIAR) shall be implemented in full.
 - (b) All mitigation, environmental commitments and monitoring measures identified in the Natura Impact Statement (NIS) shall be implemented in full.
4. Finalised cycle parking stands throughout the scheme shall be agreed in writing with the relevant planning authority.
5. The developer, and/or any agent acting on its behalf, shall prepare in consultation with the relevant statutory agencies, an updated Construction Environmental Management Plan (CEMP), Construction Traffic Management Plan and Construction Stage Mobility Management Plan incorporating all mitigation measures indicated in the NIS and EIAR.
6. Water supply and drainage arrangements shall comply with the requirements of the relevant planning authority.
7. Details of all signage shall be submitted to the local authority prior to the commencement of development to be held on record.
8. Comprehensive details of the proposed public lighting system to serve the proposed scheme shall be submitted to and agreed in writing with the planning authority.
 9. (a) All lighting shall be operated in such a manner as to prevent light overspill to areas outside of compounds and works areas.
 - (b) The applicant shall submit a detailed lighting plan to be held by the planning authority.
10. The developer shall monitor queuing time/delays at each works location and record traffic flows on the local road network at locations to be agreed with the local authority.
11. Noise monitoring shall be carried out at all times during the construction phase of the development.
12. All works shall be monitored by an Ecological Clerk of Works or Ecologist. Where appropriate, monitoring shall be undertaken by specialists.


13. Pre-construction surveys shall be carried out to determine the presence of protected mammal, bird or bat species.
14. Any new or improved surface water outfalls shall be constructed in a manner which protects riparian habitat and does not result in excessive erosion of such habitat.
15. The developer shall submit an Invasive Species Management Plan to the planning authority.
16. The developer shall ensure that all plant and machinery used during the works should be thoroughly cleaned and washed before delivery to the site.
17. Trees to be felled shall be examined prior to felling and demolition to determine the presence of bat roosts.
18. No ground clearance shall be undertaken and no vegetation shall be cleared during the bird breeding season from the 1st day of March to the 31st day of August, unless otherwise agreed with the planning authority.
19. The developer shall facilitate the preservation, recording and protection of archaeological materials or features that may exist within the site. The developer shall:
 - a) Employ a suitably qualified archaeologist, and
 - b) Provide arrangements, acceptable to the planning authority, for the recording and for the removal of any archaeological material which the authority considers appropriate to remove.
20. All works to protected structures and structures of heritage interest shall be monitored and recorded by an architectural conservation specialist, Re-instatement Method Statements shall be submitted to the planning authority to be held on file.
21. The site shall be landscaped in accordance with the comprehensive scheme of landscaping submitted. Final details of which shall be submitted to, and agreed in writing with, the planning authority.
All planting shall be adequately protected from damage until established.
22. The National Transport Authority shall also employ the services of an appropriately qualified arboriculturist and landscape architect for the full duration of the proposed works.
23. Prior to the removal of trees, hedging and planting, the National Transport Authority shall consult with, and advise, the relevant landowner of the species, size, and location of all replacement vegetation.





Rinne an Bord Pleanála, an 28 Eanáir 2025, i bhfeidhmiú na gumhactaí a dhílsítear dō le halt 51 d'Acht na mBóithre, 1993, arna leasú, ordú chun an bóthar beartaithe arna chur isteach ag an Udarás Náisiúnta lompair a cheadú faoi réir coinníollacha.

Achoimritear coinníollacha chinneadh an Bhoird mar a leanas:

- Déanfar an scéim bheartaithe a sheoladh águs a chur i gcrích i gcomhréir leis na pleananna agus na sonrái a taisceadh i dteannta an iarratais, seachas de réir mar is gá ar shíl eile chun na coinníollacha seo a leanas a chomhlionadh.

- (a) Déanfar an soilsíú ar fad a oibriú i slí a gcoiscfidh sceitheamh solais go limistéir atá lasmuigh de na compúin agus de na limistéir oibre.
- (b) Cuirfidh an t-iarratasóir pleán soilsithe mionsonraithe isteach lena shealbhú ag an údarás pleanála.
- Déanfaidh an forbróir faireachán ar agai ciúala/ar mhoilleanna ag gach láthair oibreachá agus taifeadfaidh sé sruthanna tráchta ar an ngréasán bóithre áitiúla ag láithreacha atá le comhaontófar leis an údarás áitiúil.
- Déanfar faireachán ar thorann i gconaí le linn na céime tógála den fhorbairt.
- Déanfaidh Cléireach Éiceolaíoch Oibreachá nó Éiceolaí faireachán ar na hoibreacha ar fad. I gcás gur cuí, déanfaidh speisialtóirí faireachán.

13. Déanfar surbhéanna réamhthóngála chun a shuí an bhfull speicis mhamaigh, éin nó ialtóige atá faoi chosaint i láthair nó nach bhfuil.

14. Déanfar aon sruthanna éalaithe nua nó feabhsaithe uisce dromchla a thógáil ar bhealach a gcosnóidh gnáthóga bruachánacha agus nach dtiocfaidh creimeadh iomarcach na ngnáthóga sin chun cinn mar thoradh air.

15. Cuirfidh an forbróir Pleán Bainistíochta Speiceas Ionrach faoi bhráid an údarás pleanála.

16. Cinnteoidh an forbróir gur cheart an gléasra agus an t-innealra ar fad a úsáidfear le linn na n-oibreaca a ghlanadh agus a ní go criochnúil sula seachadfaí chuig an láithréan iad.

17. Déanfar na crainn atá le leagan a scrúdú sula ndéanfar iad a leagan agus a scartáil chun a shuí an bhfull faraí ialtóg i láthair iontu nó nach bhfuil.

18. Ní dhéanfar aon ghlanadh talún, agus ní ghilanfar aon fhásra le linn shéasúr goir na n-éan ón 1ú lá de Mhárta go dtí an 31ú lá de Lúnasa, mura gcomhaontaítear a mhalaírt leis an údarás pleanála.

19. Éascoidh an forbróir caomhnú, taifeadadh agus cosaint ábhar seandálaíochta nó sainghneáithe seandálaíochta atá ann laistigh den láithréan. Déanfaidh an forbróir na nithe seo a leanas:

- Seandálaí a bhfull na cállochtaí cuí aige/aici a fhostú, agus
